## Are you an eenie, meenie, meinie, moe photographer?

Photographers have told me many reasons for their declining businesses. One reason that I don't hear I call the **eenie meenie effect**. Children use the expression as a random way of selecting the next person to do something. The key word is *random*. Many photographers offer work at about the same level. They show samples of work that are appealing...but very similar to the work of other photographers that are close by. When things are very similar, shoppers go shopping! They can look on the Internet. They can go from store to store. They can look at the Yellow Pages. Photographers often use the same selling points (i.e. years of experience, awards won, fast service, etc.) Today's consumers are beyond that. For many people, choosing a photographer is an almost random process because everyone "looks alike after a while." It's very difficult to differentiate yourself from the competition, right? No!!!!

Some photographers do very well at differentiating themselves. Denis Reggie, for example, has become very famous by creating a niche. Others are not as famous, but have created their own unique niches. Some follow a suggestion that I heard Charles Lewis articulate many years ago when he said, "Successful people do the things others don't want to do." Have you ever heard of Elsa Dorfman, Rob Gibson or Gary Auerbach?

- Elsa Dorfman ([www.elsa.photo.net](http://www.elsa.photo.net)), based in Cambridge, Massachusetts, shoots only two (2) images per portrait session! Her images are 20x24 Polaroid prints that she takes with one of only a handful of the original Polaroid cameras made for that size film. The client selects one on the spot and pays \$2500. If they want both, they get a slight discount for the second image.
- Rob Gibson ([www.civilwarphotography.com/gibson/index2.html](http://www.civilwarphotography.com/gibson/index2.html)) has the only commercial wet plate portrait studio in the United States (and probably the world). He specializes in Civil War type portraits. His studio is located near the Gettysburg Battle Field in Pennsylvania. He charges about \$100 per portrait. His studio is set up so that you can see how your portrait is being processed the old fashioned way.
- Gary Auerbach ([www.platinumphotographer.com](http://www.platinumphotographer.com)) portraits are made via the platinum process. He's based in Tucson, Arizona, where you can "process" your pictures using the sun. For about a thousand dollars, the typical client can have a platinum portrait.

If they moved to your block, would they be competition for you? They certainly would be offering something that isn't available in the metropolitan area. It's easy to be an eenie meenie photographer because that's what we've been taught for our entire lives. Since everyone else does it...we should do the same thing. It seems obvious, until you look at your bottom line and see it's turning from black to red. Is it time to try something new? That doesn't mean shutting down your current operation and doing something that you may think is bizarre. However, would it hurt much to try to add something that you don't do normally? Finding your own niche may be fun...and profitable.

**"Wedding Photography... Never a Dull Moment."**

It was a beautiful August day last summer. Perfect skies and a perfect breeze made the perfect day for a perfect New York wedding. My friend Scott and I loaded the car and headed to Manhattan where we were booked to shoot a high-end church wedding. We arrived at the Mandarin Oriental Hotel, which overlooked Columbus Circle, and set up to shoot formals of the bride, bridesmaids and family members in this opulent suite.

Picture this scene, some 60 floors over Manhattan: Three rooms filled with a gorgeous bride and bridesmaids all half dressed and sipping imported bubbly, while a team of fussy makeup artists and hair stylists rushed to improve upon perfection. Music blared, glasses clinked and laughter filled the air. The bride's exquisite, hand-made Italian silk gown hung from a light fixture and flowed down to cover a king size bed. It was perfect.

Scott and I grabbed cameras and switched into paparazzi mode. Five minutes before the bride was to get dressed we here a **POP** like a gunshot from the bedroom. A sprinkler over the bed

had blown and gallons of rusty water began gushing from the sprinkler and completely soaked this stunning bridal gown. Bridesmaids went diving through the air trying to prevent a fashion emergency. Hair and makeup were trashed, along with most of the clothes and the bridal gown. Everybody formed a relay line to rescue items of clothing and personal effects as 2 to 3 inches nasty of swamp water filled the suite.

We were all in a daze just standing in the hall, unsure of what had just happened or what we should do when the bride came out. She was clad in a dripping wet nightgown, barefoot, holding a bottle of champagne in one hand and a toothbrush in the other. After an awkward moment of silence she raised both into the air and shouted “I’ve got what I need and this wedding is going to happen!” She picked up a phone, called the desk and in a calm but firm voice informed them of what had occurred, and then proceeded to tell them “I want a team of people to relocate us into a new suite and I need a dry-cleaner RIGHT NOW!”

Moments later the hotel SWAT team arrived and everything got moved. The hair and makeup elves got to work again and all the damaged clothes were whisked away for repair. It started to look at this point like we might actually make it to the church on time. Finally the bridal gown returned, dry and with most of the stains removed. Unfortunately the cleaners had also removed the hundreds of decorative silk flowers and had sent these back separately in a big cardboard box. I then realized that a photographer’s best friend in such a situation is nothing made by Nikon, Canon or Hasselblad. It is Krazy Glue! Scott and I, along with a team of hotel personnel, began to furiously glue dozens of silk flowers back onto this elegant garment. It was like the Apollo 13 mission all over again. When enough flowers were in place, and the dress was wearable, we popped the bride into it and flew out the door. With a camera hanging on each shoulder, I jumped in the front seat of the Rolls and we were off. We had exactly 15 minutes to get to church. I don’t know who made it happen, but we even had police escort. Patrol cars blocked every intersection and even cleared a path as if we were a Presidential motorcade.

The ceremony took place, a little late, but it happened. We then hit Central Park for photos and made it back to the hotel in time for the reception. None of the guests had any idea about what had just transpired. The bride had her day and got a great story to tell, plus we had a wild time helping her out. When all was said and done, she went home with a smile and ordered a beautiful book of over 200 images.

**So what’s the lesson learned that day? Be prepared for anything and.....
